EXECUTIVE SUMMARY

The year 2013 was indeed challenging in the field of international counter-terrorism. Southeast Asia was not spared and Malaysia in particular was under the spotlight when in February 2013, approximately 200 militants proclaiming to be the Royal Security Force of the Sultanate of Sulu illegally entered Lahad Datu and subsequently killed ten (10) Malaysian security personnel. This brazen act of defiance and open hostility was however thwarted by our security forces. The incursion was also the catalyst for the formation of the Eastern Sabah Security Zone (ESSZONE) and the Eastern Sabah Security Command (ESSCOM) with the express purpose of strengthening security in the eastern part of Sabah.

It is also significant to note that other developments such as radicalised individuals in the region travelling to Syria and getting involved in militant activities there, as well as homegrown self-radicalised individuals being indoctrinated via the Internet continue to be a source of concern for countries in the region.

While regional terrorist groups such as the Jemaah Islamiyah (JI) have been weakened due to robust counter-terrorism operations, new and relatively small-sized groups, networks and cells have been emerging since 2010. Other active groups (local and transboundary) which continue to pose problems in the region are the New People's Army (NPA) and the Abu Sayyaf Group (ASG) in the Philippines and East Indonesian Mujahideen and Kumpulan *Mujahiddin Indonesia* in Indonesia.

The terrorists' ability to adapt and evolve to maintain their presence in the region and beyond continues to be a major concern for counter-terrorism officials. The challenge for Malaysia therefore, is to continue to build strong and dynamic counter-terrorism approaches and to never be lulled into complacency. In lieu of that, the Southeast Asia Regional Centre for Counter-Terrorism (SEARCCT), as the country's Centre for capacity building and research on terrorism and counter-terrorism related matters, will continue to train and enhance the capacity and knowledge of Malaysia's and the region's security forces, administrators and policy makers on the subject matter.

Since the establishment of SEARCCT in 2003, the Centre has conducted 129 capacity building programmes attended by 3906 participants from various countries (details are attached as **ANNEX A**). In 2013 alone, the Centre conducted 17 capacity building programmes attended by 432 participants including 73 foreigners (16.89%). The participants were from various relevant agencies in Malaysia as well as from the ASEAN states and beyond.

In 2013, SEARCCT continued to collaborate with various local and international agencies as well as programmes namely, the Malaysian Prison Department, the Malaysian Technical Cooperation Programme (MTCP), Canada, France, New Zealand and the United Nations' Counter-Terrorism Executive Directorate (CTED). In 2013, SEARCCT for the first time collaborated with the Centre on Global Counter-Terrorism Cooperation (CGCC) to conduct a programme on community policing and countering violent extremism. The year 2013 was also the first time SEARCCT conducted two (2) programmes under the sponsorship of the MTCP.

SEARCCT also published various works on the study of terrorism and counter-terrorism. In 2013, the Centre published a monograph on Jemaah Islamiyah which chronicled the birth and development of JI, particularly in Malaysia. The Centre had also published another volume of 'SEARCCT's Selection of Articles' which compiled works on terrorism and counter-terrorism issues written by experts in the field from around the world while three (3) more articles at the national and international levels are pending publications.

Apart from that, SEARCCT was also involved in conducting public awareness programmes such as the 'SEARCCT's University Lecture Series'. This series of talks was meant to engage local undergraduates, and both to listen and speak into their lives on the dangers of radicalisation. In 2013, SEARCCT delivered such lectures to five (5) universities around Malaysia, reaching approximately 700 undergraduates.

Another public awareness programme conducted by SEARCCT was the 'SEARCCT's Looking Back Lecture Series'. This lecture series looked into Malaysia's role in defeating the terrorist insurgency and also endeavored to relook and re-examine the critical steps that were crafted and executed during those difficult times. In 2013, the Centre invited the founding director of VAT 69, Dato' A. Navaratnam, to give a lecture on the significance of VAT 69 in combating terrorism. Another programme under the banner of SEARCCT's public awareness programme was the 'SEARCCT's Public and Internal Lecture Series'. This was done by engaging with renowned experts from both within and beyond Malaysia in the field of counter-terrorism.

SEARCCT conducted its capacity building programmes, research activities and public awareness programmes based on the Centre's seven (7) flagships; Investigation and Legal Aspects; Chemical, Biological, Radiological, Nuclear and Explosive (CBRNE) and Crisis Management; Aviation, Maritime and Transportation Security; Cyber Terrorism; Prevention and Rehabilitation; Terrorism Financing; and Youth and Terrorism.

This annual report presents a summary of SEARCCT's activities in 2013.

PLANNING AND TRAINING DIVISION

The Planning and Training Division is tasked to organise and conduct capacity-building programmes for local and foreign government officials, enforcement and security officials on counter-terrorism issues in collaboration with established think-tank institutions and international organisations. In 2013, the Division conducted 17 capacity-building programmes with a total of 432 participations both at the local and international levels. The full list of SEARCCT's programmes in 2013 is attached as **ANNEX B**.

1. PREPARATION OF PROGRAMMES

In ensuring that the Centre meets the needs of its clients as well as the local and foreign collaborators, annual coordination meetings are conducted with relevant local agencies as well as foreign and international collaborators in the third or fourth quarter of every year for feedback, comments and suggestions for programmes to be conducted in the following year.

2. BUDGET

SEARCCT has limited facilities and limited resources to run its training programmes. Over the years, SEARCCT had relied very much on external training resources from its foreign and international collaborators particularly in providing the financial resources to invite foreign experts and participants from countries within and beyond the region.

The total training expenditure for 2013 amounted to RM 501,000.00. The Division hopes for a more substantial training budget for the coming years to cater for the increase in the number of training programmes as well as to enhance the quality of the programmes.

3. PARTICIPANTS

In 2013, a total of 432 (359 local and 73 foreign) participants attended the 17 training programmes conducted by the Centre. The foreign participants were from the ASEAN member states i.e. Brunei (7), Cambodia (1), Indonesia (9), Laos (5), Myanmar (4), The Philippines (9), Singapore (4), Thailand (9) and Vietnam (3). The rest of the foreign participants were from countries beyond the ASEAN region such as Bhutan (1), Jordan (1), Kyrgyzstan (2), Mauritius (1), Oman (1), Pakistan (1), Saudi Arabia (1), Sri Lanka (4), Tajikistan (2), Timor Leste (3), Tunisia (1), Uzbekistan (1) and Yemen (3).

4. LOCAL SUPPORT AND COLLABORATORS

In 2013, SEARCCT continued to receive unwavering support from relevant ministries, agencies and private institutions in Malaysia in terms of collaboration and participation.

SEARCCT is highly appreciative of such cooperation and support from local strategic partners, namely the Ministry of Home Affairs, the Ministry of Defence, the Ministry of Health, the National Security Council and the Office of the Chief Government Security Officer of the Prime Minister's Department, the Attorney General Chambers, the Royal Malaysia Police, the Malaysian Armed Forces, the Fire & Rescue Department, the Prison Department, the Immigration Department, the Royal Customs & Excise Department, the Civil Defence Department, the Department of Civil Aviation, the Marine Department, the Malaysian Maritime Enforcement Agency (MMEA), the Chemistry Department, the Atomic Energy Licensing Board (AELB), the Central Bank of Malaysia as well as CyberSecurity Malaysia from the Ministry of Science, Technology & Innovation.

Private agencies had also cooperated in SEARCCT's training programmes in 2013. The agencies included the Port of Tanjong Pelepas (PTP), Johor, Malaysia Airline System (MAS), Malaysia Airports Holding Berhad (MAHB), Air Asia Berhad, KLCC, KL Sentral, Malaysia International Shipping Corporation Berhad (MISC) and the Malaysian Maritime Academy.

5. FOREIGN SUPPORT AND COLLABORATORS

Since its establishment in 2003, SEARCCT has had numerous collaborations and support from foreign governments and agencies. In 2013, the Centre's main collaborators were New Zealand and Canada whereby each country had jointly organised three (3) training programmes with SEARCCT respectively. This was followed by France with two (2) training programmes conducted in collaboration with SEARCCT while three (3) training programmes were also co-organised with international agencies such as United Nations Counter-Terrorism Executive Directorate (CTED) and Global Centre for Counter-Terrorism Cooperation (CGCC).

6. EVALUATION OF PROGRAMMES

All participants of SEARCCT's training programmes were requested to give their comments and feedback in an Evaluation Form provided at the end of each programme. The purpose was to gauge the effectiveness of the training conducted and the logistics arrangement rendered. For the year 2013, the majority of the participants had given an average grade of five out of seven in almost all of the areas evaluated. However, the most common issue that was raised by the participants was pertaining to the short duration of the training programme. SEARCCT will endeavor to address this while taking into account its financial constraints.

PROGRAMMES IN 2013

7.1 Terrorism 101 (1/2013)



SEARCCT commenced the year 2013 with an introductory course entitled 'Terrorism 101' held in Cameron Highlands, Pahang from 20 – 21 February 2013. The course was attended by 32 local officials from relevant ministries, agencies and higher learning institutions including the Prime Minister's Office, National Security Council (NSC), Ministry of Higher Education, Royal Malaysian Police (RMP), Malaysian Armed Forces, Immigration Department, Perak Education Department, Pahang Education Department, Kelantan Education Department, *Universiti Malaysia Pahang, Universiti Malaysia Terengganu, Universiti Pendidikan Sultan Idris, Universiti Teknologi Mara* in Perak, Pahang and Kelantan as well as *Universiti Teknologi Petronas*. The aim of the course was to provide the participants with an overview of terrorism and counter-terrorism related matters.

During the two-day programme, the participants were exposed to subjects such as the history of terrorism, tactics and strategies adopted during Malaysia's fight against the communist insurgency, the processes involved during the indoctrination of individuals into terrorist groups, namely the Jemaah Islamiyah (JI) as well as an overview of the current terrorism situation. The participants were also given the opportunity to watch a documentary entitled 'Prison and Paradise' depicting the family lives of both the perpetrators and victims of the 2002 Bali Bombings. At the end of the

course, a group discussion was conducted where the participants deliberated on the importance of deploying "soft approaches" as the primary component when countering the threat of terrorism.

Among the speakers invited to the course were YBhg. Datuk Paul Kiong, a former police Special Branch officer, who spoke on counter-terrorism operations against the communist insurgents and a rehabilitated former terrorist member who enlightened the audience on the recruitment process of JI.

7.2 CBRNE First Responder Training Programme (1/2013)



SEARCCT, in collaboration with the Canadian High Commission, conducted the 'CBRNE First Responder Training Programme (1/2013)' from 11 – 14 March 2013 at the Primula Beach Resort in Kuala Terengganu, Terengganu. A total of twenty-eight (28) participants from the Malaysian Armed Forces, Royal Malaysian Police, Fire and Rescue Department, Ministry of Health, Chemistry Department, Atomic Energy Licensing Board (AELB), Nuclear Agency Malaysia as well as officers from PETRONAS and MISC took part in the programme.

Among the speakers invited were Mr. Zulkefle Hussin of AELB who spoke on Radiology, Mr. Muhammad Fauzi Ghazali, a forensic investigation specialist from the Chemistry Department, who delivered a lecture on Chemical Agents, Indicators, Disseminators and Evidence, as well as Lt. Col. Jamal Malik of Malaysian Armed Forces who enlightened the audience on the subject

of Detection, Chemical Wind Anomalies and Military Decontamination. SEARCCT's Director of Planning and Training, ACP Ali bin Omar, also delivered a lecture on issues in terrorism and counter-terrorism.

A field visit to the Fire and Rescue Academy was also organised where participants had the opportunity to try on the Personal Protective Equipment (PPE) and participated in a demonstration of a decontamination process. The visit also involved a lecture by Mr. M. Murugiah from the Fire and Rescue Department on Response and Command Structure, Hazard Assessment and PPE.

7.3 Port Security CBRNE Training Course



The Port Security CBRNE Training Course held on 2 – 5 April 2013 was the second programme in collaboration with the Government of Canada for the year 2013. The course was held at the Bluewave Hotel in Shah Alam, Selangor and was attended by 30 Security and Fire officers from various port authorities and operators across the country including Sabah and Sarawak.

Amongst the topics discussed in the course included 'Overview of the Past, Present and Future of Terrorism Threat in Malaysia' by SEARCCT's Director of Planning and Training ACP Ali bin Omar, 'Maritime Terrorism – Current and Future Trend' by Dr. Mohd Hafizzudin Dato' Hj. Md. Mamiri of the Malaysian Institute of Defense and Security (MiDAS), Ministry of Defense, 'The Strategic Trade Act 2010' by Mr. Mohamed Shabar Abdul Kareem, Strategic Trade Controller, Ministry of

International Trade and Industry, as well as on the topic of 'The Handling of Dangerous Goods in Ports – The Port Klang Experience' by Mr. Ahmad Rizal bin Mohd Yusof from the Klang Port Authority.

During the four-day course, field visits to the Westport Training Centre at Pulau Indah, Port Klang and the Megaport Security Initiative Unit of the Royal Malaysia Customs and Excise Department were organised with the aim of equipping the participants with the basic knowledge on "CBRNE Responses and Hazard Assessment Mechanism" as well as "Personal Protection against CBRNE Threats for First Responders". The participants were also able to try on various type of Personal Protection Equipment (PPE) during a practical training and demonstration session at the Westport Police Complex.

7.4 Seminar on Management and Rehabilitation of Terrorism Offenders



This four-day seminar was jointly organised by SEARCCT and the Prison Department of Malaysia at the Correctional Academy of Malaysia, Langkawi (CAML) from 15 April to 18 April 2013. Twenty-six (26) participants from relevant agencies and ministries such as the Prison Department, Royal Malaysian Police, Malaysian Armed Forces, Ministry of Home Affairs and Department of Islamic Development (JAKIM) attended the course.

With the aim of exposing the participants on the general perspective of terrorism and counterterrorism as well as the implementation of prevention, rehabilitation and de-radicalisation techniques, the seminar started with an overview of the "Past, Current and Future Trends of Terrorism in Malaysia" followed by a lecture on "Human Rights and the Rights of Detainees". Dr. Mohd Zaidi Ismail from the Institute of Islamic Understanding (IKIM) also briefed the participants on "Jihad and Terrorism from the Islamic Perspective".

Aside from that, the Seminar also covered topics such as "Rehabilitation of Terrorists from Religious Perspectives", presented by Associate Professor Dr. Wan Suhaimi bin Wan and "An Overview of the Prison Rehabilitation System" as well as "Rehabilitation of the Terrorists from Prison Experience" by Supt. Adinaraina Subramaniam from the Prison Department.

7.5 Terrorism 101 (2/2013)



On 15 – 16 May 2013, SEARCCT conducted its second series of 'Terrorism 101' in Melaka. Twenty-six (26) participants from the uniformed services, relevant departments and agencies attended the course that was designed to equip junior government officers with knowledge of terrorism and counter-terrorism in the region and beyond.

The invited speakers included Dato' Paul Kiong and a former Jemaah Islamiyah (JI) leader amongst others. A new module was introduced in lieu of the March 2013 Lahad Datu Incursion where an officer from the Royal Malaysia Police was invited to deliver a lecture on the background of the incursion as well as on the formation of ESSCOM.

At the end of the course, participants were requested to deliberate on various terrorism and counter-terrorism issues as well as the role they could play in this area. With such interaction, it was hoped that a better awareness and understanding of the subject matter will be developed, leading to a more comprehensive and coordinated approach in dealing with the scourge of terrorism.

7.6 Regional Cybercrime Workshop: Cybercrime Linked with Terrorism



SEARCCT, in collaboration with the International Cooperation Department (DCI) of the Ministry of Interior, Republic of France, successfully conducted a course entitled 'Regional Cybercrime Workshop: Cybercrime Linked with Terrorism' from 28 – 30 May 2013 in Kuala Lumpur. Thirteen (13) regional participants from Brunei, Indonesia, the Philippines, Thailand and Vietnam as well as 11 Malaysian participants from the Ministry of Foreign Affairs, Ministry of Home Affairs, Royal Malaysia Police, the Malaysian Armed Forces, Office of the Chief Government Security Officer, the Attorney General's Chambers, CyberSecurity Malaysia as well as University Technology Petronas took part in this workshop.

The workshop was facilitated by three (3) French experts namely, Colonel Alain Robert Sevilla, Commissaire Sylvain Joli and Mr. Fabrice Pradier. Among the subjects covered were "Policies and Legal Measures on Cybercrime", "Theories and Concept of Cyber Terrorism", "Tactics and Strategies of a Cyber Attack" and "Investigative Strategies" and "Intelligence Techniques in fighting

Cybercrime linked to Terrorism". Case studies of past investigations conducted in France were also shared with the participants.

The objective of the workshop was to provide participants with the knowledge and skills to deal with computer-related terrorist activities and information technology security issues especially in the area of protecting government infrastructure from cyber terrorism.

7.7 2nd Regional Workshop on International Joint-Investigations for Southeast Asian States



On 4 – 7 June 2013, SEARCCT, with the support of the Government of New Zealand, collaborated with the United Nations Counter-Terrorism Executive Directorate (CTED) to conduct the '2nd Regional Workshop on International Joint-Investigations for Southeast Asian States' in Langkawi, Kedah. This was a continuation of the first 'Regional Workshop on International Joint-Investigations' held in Kuala Lumpur from 26 – 28 June 2012. Twenty-four (24) participants from the ASEAN member countries including eight (8) from Malaysia attended the programme.

Experts from various international and regional organisations as well as national law enforcement agencies were invited to execute the modules prepared for the programme, including experts from CTED, United Nations Office on Drugs and Crime (UNODC), South European Law Enforcement Centre (SELEC), INTERPOL, ASEANAPOL, New Zealand Police, Australian Federal Police, United States' Department of Justice and the Supreme People's Procuratorate of the Republic of China.

The workshop took place in a conducive environment where the participants and experts interacted openly to exchange views and experiences on various legal and practical aspects of international joint investigations. It was hoped that the workshop will further develop regional cooperation and provide a platform for collective efforts to address terrorism and related crimes, thus, enabling the prevention and effective response to terrorism and its related challenges.

7.8 CBRNE Advanced First Responder Training Programme



SEARCCT, in collaboration with the Canadian Government and the Malaysian Fire and Rescue Department, organised a 'CBRNE Advanced First Responder Training Programme' from 12-20 June 2013 at the Fire and Rescue Academy in Kuala Terengganu, Terengganu. The programme was attended by 26 officials from the Malaysian Armed Forces, Royal Malaysia Police, the Fire and Rescue Department, Minsitry of Health, Chemistry Department, Atomic Energy Licensing Board (AELB) and Nuclear Agency Malaysia.

Twelve (12) experts from various Canadian agencies were invited to facilitate the programme including from the Royal Canadian Mounted Police (RCMP), Defence Research Development Canada (DRDC), Canadian Public Health Department, Canadian Nuclear Safety Commission, Emergency Medical Services and from the Fire and Rescue Department of Canada.

7.9 Management and Rehabilitation of Terrorism Offenders (2/2013)



The second 'Management and Rehabilitation of Terrorism Offenders' programme in 2013 was held in Taiping, Perak from 26-29 August 2013. This programme was a joint collaboration between SEARCCT and the Prison Department. Twenty-seven (27) officials from the Prison Department, Royal Malaysia Police, Malaysian Armed Forces and the Department of Islamic Development (JAKIM) attended the four-day programme.

In this second edition of the programme, the participants were taken on a field visit to the Kamunting Detention Centre where arrested terrorists under the now abolished Internal Security Act (ISA) were previously detained. During the visit, participants were briefed on the challenges faced by the authorities in running the Centre. The participants also visited the Taiping Prison.

The programme was designed to expose and broaden the participants' understanding on the issues related to the management and rehabilitation of terrorism offenders.

7.10 Dynamics of Youth and Terrorism: Understanding and Countering the Issues



A seminar on 'Dynamics of Youth and Terrorism: Understanding and Countering the Issues' was conducted by SEARCCT in Kuala Lumpur from 9 to 14 September 2013. Funded by the Malaysian Technical Cooperation Programme (MTCP), this one-week programme was attended by 31 participants with diverse backgrounds from ASEAN member countries as well as the South and Central Asia regions.

The seminar focused on various terrorism and youth issues namely understanding youth, the lessons learned on youth and terrorism, young professionals' involvement in terrorism and the law enforcement perspectives of the issue. The concept of 'Winning the Hearts and Minds' was also discussed.

Participants were also taken on a field trip to the Setia Ikhlas National Service Camp (PLKN) in Semenyih, Selangor where they were first briefed on the background of the National Service Programme followed by a cultural show by the National Service trainees. During the country presentation session, the participants shared their views on youths' involvement in terrorism as well as the steps taken in their respective countries to deal with the issue.

The one-week seminar provided the participants with an opportunity to learn, share, engage and experience the various issues on youth and terrorism. It also gathered Malaysia's resource persons as speakers and showcased Malaysia's multi-pronged and multi-faceted strategies in confronting the issue.

7.11 Countering Financial Terrorism Workshop



On 24 – 26 September 2013, SEARCCT collaborated for the second time with the International Cooperation Department (DCI) of the French Ministry of Interior to conduct another workshop entitled 'Countering Financial Terrorism Workshop'. The workshop was attended by 22 local participants from government bodies and agencies such as the Ministry of Foreign Affairs, Royal Malaysia Police, the Malaysian Armed Forces, the Royal Malaysian Customs, the Central Bank of Malaysia, the Registrar of Societies, the Companies Commission of Malaysia and the National Security Council.

It was facilitated by two French experts in financial fraud, Mr. Jean Pierre Michau and Mr. Yves Godiveau. The workshop discussed various related subjects which included 'Updating of the FATF Recommendations and Actions in Countering Financial Terrorism', 'Underground Economy to Finance Terrorism', 'Micro Financing Terrorism: Links between Crime and Terrorism', 'Links

between Money Laundering and Financing Terrorism' as well as 'Seizure and Forfeiture of Criminal / Terrorist Assests'.

7.12 Enhancing Port Security against Terrorism



The 'Enhancing Port Security against Terrorism' course was held from 8 to 10 October 2013. The participants were selected from 11 port authorities and operators across the country while 11 others were from the Ministry of Foreign Affairs, Ministry of Home Affairs, the National Security Council and the Office of the Chief Government Security Officer (CGSO), Prime Minister Department, the Royal Malaysia Police, The Royal Malaysia Navy, the Royal Malaysia Customs, the Immigration Department, the Fire and Rescue Department and the Malaysian Maritime Enforcement Agency (MMEA).

On the second day of the programme, the participants were taken on a study visit to the Westport facilities at Pulau Indah, Port Klang where they were briefed on the security measures adopted at the port. This was then followed by another study visit to the Megaport Security Initiative Unit of the Royal Malaysia Customs and Excise Department.

On the last day, a table-top exercise was held to discuss and debate at length on the best measures that could be employed in real-life scenarios. This programme was designed with the aim to create the necessary security awareness and to understand the required security measures against possible attacks on a port facility.

7.13 Aviation Security Workshop



The 'Aviation Security Workshop' was held from 28 to 31 October 2013 in Kuala Lumpur. It was attended by 20 local participants from various agencies including the Department of Civil Aviation, Malaysian Air Force, Royal Malaysia Police, Royal Customs Department, Immigration Department, Malaysia Airport Holding Berhad, Malaysia Airlines and Air Asia.

The four-day workshop, conducted in collaboration with the New Zealand High Commission, was facilitated by Mr. Hugo Porter and Mr. William Lilley from the New Zealand Civil Aviation Authority (NZCAA). Participants were also taken on a visit to the Air Asia Academy in Sepang where they were briefed by Mr. Gopinath Bakhinathan on Air Asia's Security Operations.

The objective of the workshop was to provide a platform for practitioners and relevant officers to discuss matters related to aviation security.

7.14 Counter-Terrorism and Violent Extremism through Community Policing



SEARCCT, in collaboration with the United Nations Counter-Terrorism Committee Executive Directorate (CTED) and the Center on Global Counter-Terrorism Cooperation (CGCC) conducted a one-day workshop entitled 'Counter-Terrorism and Violent Extremism through Community Policing' in Kuala Lumpur on 7 November 2013.

The aim of the workshop was to provide a platform for national law enforcement agencies and community policing experts to exchange ideas, experience and good practices in community policing and to discuss its applicability to counter the threat of terrorism and violent extremism.

The workshop was attended by 20 local officials from various agencies including the Royal Malaysian Police (RMP). To ensure the success of the workshop, speakers from international and local agencies including, the New Zealand Police, Royal Canadian Mounted Police, Federal Police of Belgium, Eastern Sabah Security Command (ESSCOM) and the Royal Malaysia Police's Special Task Force (Operations / Counter-Terrorism) were invited to share their experiences and knowledge at the workshop.

7.15 CBRN – First Responder Training Programme (2/2013)



The CBRN – First Responder Training Programme' was the second programme conducted by SEARCCT under the sponsorship of the MTCP. The programme, which was held in Kuala Terengganu, Terengganu from 11-15 November 2013, was attended by 30 participants from Southeast Asia, South Asia, Central Asia and beyond. The trainers and speakers were experts from the Atomic Energy Licensing Board (AELB), the Chemistry Department, the Fire and Rescue Department, the Malaysian Armed Forces, the Ministry of Health and the Royal Malaysian Police.

The programme provided the participants with theoretical concepts of CBRN indicators, detection, and decontamination procedures. The terrorist modus operandi for a CBRN attack, the importance of hazard assessment and the control and command during emergency response was also thoroughly examined.

The programme also provided the participants with hands-on skills during a practical session on Personnel Protective Equipment (PPE) and Detection Methods which was conducted at the Fire and Rescue Academy in Wakaf Tapai, Terengganu. There was also a demonstration on the concept of "Mass Decontamination and Technical Decontamination" for injured and non-injured victims. Participants were also taken to the Petronas East Coast Regional Office (ECRO) in Kerteh, Terengganu for a study tour.

7.16 Training of Trainers (TOT): CBRNE First Responder Programme



SEARCCT organised a 'Training of Trainers (TOT): CBRNE First Responder Programme' from 20 to 22 November 2013 in Bali, Indonesia. It was attended by 10 CBRNE trainers as well as SEARCCT officials.

A visit was organised to the Bali General Hospital where participants were given a briefing on the management of mass casualties especially when handling terrorism cases. The participants were also briefed on the 'Threat of Terrorism in Indonesia', presented by Mr Johannes Manginsela, the Deputy Director for Multilateral Cooperation, National Counter-Terrorism Agency, Republic of Indonesia.

The objective of the programme was to enhance the knowledge and skills of the participants on CBRNE: First Responder.

7.17 Terrorism 101 (3/2013)



SEARCCT conducted its third installment of the 'Terrorism 101' course specifically for the Prison Department in Kota Kinabalu, Sabah from 26 – 27 November 2013. While the course included the existing modules of 'Terrorism 101', an additional subject was introduced: 'ESSCOM and the Prison Department' which was delivered by YBhg. Dato' Nadzer Nordin, Head of Intelligence, ESSCOM.

A group exercise was then conducted where participants were given a case study on the 7/7 London Bombing in which they were subsequently requested to present their views as well as their course of actions in dealing with a specific terrorism attack.

8. PROGRAMMES IN 2014

SEARCCT plans to conduct 16 programmes for the year 2014. The list of Training Courses is attached as **Annex C**.

RESEARCH CX PUBLICATIONS DIVISION

RESEARCH AND PUBLICATIONS DIVISION

The Research and Publications Division's core function revolves around research, public awareness and publications. Its main research areas include youth and extremism, cyber terrorism, radicalisation, countering the terrorist narrative and the terrorist organisation Jemaah Islamiyah. For the year 2013 the Division had presented 38 papers at both national and international levels to approximately 2400 individuals. The Division's outreach programmes include; i) The SEARCCT's University Lecture Series, ii) The SEARCCT's Looking Back Lecture Series, and iii) The SEARCCT's Internal Lecture Series. For the year 2013, the Division had published one (1) article and two (2) monographs (ANNEX D). Three (3) more articles at the national and international levels are pending publication.

WORK SCOPE

This Division is responsible for identifying and conducting research and publication activities related to terrorism and counter-terrorism.

2. RESEARCH PERSONNEL

The Research and Publications Division consists of one (1) director, two (2) research officers, one (1) librarian, one (1) assistant librarian and one (1) administrative clerk. There is at present an ongoing process to fill the posts of two (2) research officers.

4. PAPERS/LECTURES PRESENTED AT NATIONAL AND INTERNATIONAL LEVELS

The Research and Publications Division has had the opportunity to present its views on terrorism and counter-terrorism at various national, regional and international seminars, conferences and workshops. In 2013, The Division had been invited to deliver 33 papers that have reached more than 2,000 individuals at the national level and five (5) papers that have reached more than 400 people at the international level on various subjects in the field of terrorism and counter-terrorism. All in all, the Division had presented its research findings to approximately 2,400 individuals at both the national and international levels. The full list of the Division's speaking engagements in 2013 is attached as **Annex E**.

5. PUBLICATIONS

In 2013, the Division had published one (1) article and two (2) monographs. Among the works include:

6. PUBLIC AWARENESS ACTIVITIES

Besides the core research activities, the Division is also involved in public awareness activities. These include:

6.1 SEARCCT's Looking Back Lecture Series

The purpose of this series was to showcase Malaysia's successful counter insurgency efforts against the communist insurgents and to highlight possible lessons that could be applied in today's context. In 2013, SEARCCT invited Dato' A. Navaratnam, the first Director of VAT 69, PDRM to deliver a lecture on the formation and significance of VAT 69 in combating terrorism.

6.2 SEARCCT's University Lecture Series

The purpose was to speak and engage with undergraduates in Malaysian universities on the dangers of extremism and terrorism. In 2013, the Research Division was invited to *Universiti Malaysia Terengganu (UMT)*, *University Teknologi Mara (UiTM)*, *Universiti Teknologi Petronas (UTP)*, *Universiti Utara Malaysia (UUM) and Universiti Malaysia Sarawak (UNIMAS)* to speak to approximately 700 undergraduates altogether. The Division also conducted a 'focus group' engagement to get a better feel on the undergraduates' perception and knowledge on terrorism and counter-terrorism issues.

6.3 SEARCCT's Internal Lecture Series

The Division invited experts in the field of terrorism and counter-terrorism to speak to SEARCCT and Wisma Putra officials. In 2013, SEARCCT invited YBhg. Dato' Hamid Bador, Deputy Director of Special Branch twice to give his views on both the internal and external security threats to Malaysia.

7. COOPERATION AND COLLABORATION IN 2013

Realising the need to work together and learn from one another, the Division collaborated with various national and international entities.

7.1 National Level:

- Delivered seven (7) lectures for Institut Tadbiran Awam Negara (INTAN);
- · Delivered five (5) lectures for the Prison and Correctional Facilities, Malaysia;
- Delivered four (4) lectures for the Institute of Diplomacy and Foreign Relations (IDFR);
- Delivered three (3) lectures for the Royal Malaysia Police College; and
- Delivered one (1) lecture for the Maktab Pertahanan Angkatan Tentera.

7.2 International Level:

Japan

Presented a paper at the Counter Radicalisation Workshop in February 2013.

United Nations Organisation on Drugs and Crime (UNODC)

 Collaborating (in principle) with the United Nations Organisation on Drugs and Crime (UNODC) to conduct research on the issue of radicalisation and deradicalisation in the region.

S. Rajaratnam School of International Studies (RSIS), Nanyang Technological University (NTU), Singapore

- The Division was invited to present its research findings at a conference in RSIS.
- RSIS had also invited the Division to write on the subject of Community Counter Ideological Response: Reaching Out to the Youth for its publication.
- The Division had also tapped on the expertise of RSIS by inviting their academics to both deliver papers as well as write in the Centre's publications.

German – Southeast Asian Centre of Excellence for Public Policy and Good Governance (CPG) in Bangkok, Thailand

- The Division was invited to present its research findings at a workshop organised by CPG.
- CPG had also invited the Division to contribute a chapter entitled Youth: The Challenge of Extremism and Terrorism for a book on political violence that would be published by them.

Global Counter-Terrorism Forum (GCTF)

- GCTF is an informal, multilateral counter-terrorism platform that focuses on identifying critical civilian counter-terrorism needs by mobilising the necessary expertise and resources to address such needs.
- The Division was invited to Washington to present a paper on the subject of countering violent extremism among the youth.

8. SEARCCT RESOURCE CENTRE

The Division oversees the SEARCCT Library. The library has a growing collection of books, journals, CD's, VCD's and DVD's on terrorism and counter-terrorism issues. At present, the library has approximately 1,363 books, 270 CD's, VCD's and DVD's, 350 magazines and journals and 130 copies of seminar/course reports.

9. OPPORTUNITIES

The Research and Publications Division has tremendous potential to create a significant impact by:

- Playing a leading role in terrorism and counter-terrorism research in Malaysia and the region;
- Addressing national security concerns through research and 'horizon scanning';
- Enhancing the quality of the SEARCCT's Public Lecture Series, SEARCCT's Internal Lecture Series, SEARCCT's Looking Back Lecture Series and the SEARCCT's University Lecture Series;
- · Increasing the breadth and depth of public awareness programmes and lectures to include:
 - > Academicians
 - Youths
 - > Legal enforcement officers
 - > Military officers
 - > Local and foreign diplomats
- Collaborating with established institutes of higher learning and think-tanks to increase SEARCCT's profile as well as to build internal capacity.

10. THE FUTURE

There is again tremendous potential for the Research and Publications Division in the field of counter-terrorism and these include:

10.1 Research

 Conducting qualitative and quantitative research work on terrorism and counterterrorism issues of significance to Malaysia and the region.

10.2 Going to the Ground

 'Turun padang' to feel, understand and know the situation on the ground to be better able to document and analyse the issue of terrorism and counter-terrorism.

10.3 Speaking, Writing and Publishing

- To articulate Malaysia's position on terrorism and counter-terrorism by speaking at the national, regional and international fora.
- To disseminate SEARCCT's research work to a wider audience by writing in local and international publications.

10.4 Reaching Out and Meeting the Research Needs in the Counter-Terrorism Field

 Finding niche areas, critically evaluating issues and providing feasible, practical and sustainable recommendations.

1. ORGANISATIONAL STRUCTURE: MANPOWER


SEARCCT has a total of 55 posts. At the end of the year 2013, 47 posts were filled while eight (8) other posts were vacant. The Centre has officers from the uniformed services on secondment basis which includes two (2) officers from the Royal Malaysia Police (RMP) and one (1) officer from the Malaysian Armed Forces (MAF). In addition, the vacant posts for 2013 comprised the posts of Director of Administration and Finance (PTD M48), two (2) Research Officers (Open Post), one (1) General Clerk, two (2) Technicians (J17) and two (2) General Staff (R1).

2. FINANCIAL PERFORMANCE

In 2013, the allocation given to SEARCCT was RM 5,418,100.00 which shows an increase of 10% from the budget received in 2012. SEARCCT's total expenditure for the year was RM 4,757, 499.04 (87.81%).

The bulk of the expenditure mainly went to salary and emolument, capacity building and training programmes, publications, research work and compulsory contractual payments. The breakdown of the allocation and expenditure for 2013 is attached as **Annex F**.


2013 FINANCIAL PEFORMANCE



3. TRAINING COURSES FOR STAFF

Recognising the need to continuously enhance the knowledge and capacity of SEARCCT's staff, they were required to attend at least seven (7) days of training either at national or international levels. Out of the 47 personnel, 45 (96%) attended courses for at least seven (7) days while the other two 2 (4%) attended one to six days of training.

4. SEARCCT'S MOTIVATIONAL AND TEAM BUILDING PROGRAMME

A Motivational and Team-Building Programme for SEARCCT's officers and staff was held at Holiday Inn Hotel in Penang from 1 to 3 March 2013. The main purpose of the programme was to instill a positive work culture and enhance team spirit and unity amongst the officers and staff of SEARCCT.

5. SEARCCT'S TRANSFORMATION WORKSHOP

A workshop on Transformation was held at Thistle Port Dickson Resort from 11 to 13 December 2013. The workshop was organised in line with the Public Services Department's call for all Government agencies to design a transformation plan to enhance productivity in the government sector. The workshop discussed SEARCCT's future direction in terms of policy, training programmes, research activities and organisational structure.

6. WORKING VISITS TO SEARCCT

In 2013, various agencies at both local and international levels visited SEARCCT. During the visit, participants were briefed by SEARCCT's officers on the establishment of the Centre and its core functions as a training and research Centre on counter-terrorism. These foreign agencies include:

- 6.6 Deputy Chief of Police, Hong Kong 24 October 2014.

7. SEARCCT EVENTS

7.1 SEARCCT's 10th Year Anniversary

On 1st July 2013, SEARCCT marked its 10th year of operations since its establishment in July 2003. A special prayer (Tahlil) and an evening reception were held to celebrate SEARCCT's 10th Anniversary. Besides officers and staff of SEARCCT, former staff, collaborators and families were also invited to join the celebration.



7.2 Hari Raya Open House

On 4 September 2013, SEARCCT organised a Hari Raya Open House, inviting officials from Wisma Putra, other agencies, former officials of Wisma Putra, ex-staff of SEARCCT, local and foreign collaborators.

1. OFFICIAL WEBSITE

In 2013, the ICT Unit of SEARCCT launched SEARCCT's new website. In the effort to keep the website with updated information, the contents were regularly monitored and updated by uploading latest articles published by SEARCCT, the annual prospectus, current events related to terrorism and counter- terrorism initiatives in Malaysia, as well as articles relating to the fundamentals of terrorism and counter-terrorism. Updated summary reports of training programmes conducted by SEARCCT were also published on the website. Additionally, achievements of the Client Charter were also uploaded on a monthly basis.

As of 31 December 2013, SEARCCT's website recorded a total of 14,622 visits from 128 countries around the globe. Visitors were mainly from Malaysia, United States, Singapore, France, Indonesia, Philippines, India, United Kingdom, Australia and Japan.

In 2013, SEARCCT's website was given a rating of five-star in the Malaysian Government and Portal Assessment (MGPWA) conducted by Multimedia Development Corporation (MDeC).




